1. CALL TO ORDER AND ROLL CALL

Chair Mueller called the meeting to order at 3:31 p.m. SVMPO Administrator Coxworth conducted the roll call.

2. ACCEPTANCE OF THE AGENDA

Chair Mueller asked for a motion to accept the agenda of the November 18, 2015 Regular Meeting of the Sierra Vista Metropolitan Planning Organization Board of Directors as written. Member Blanchard so moved and Member Lane seconded. The motion passed unanimously, 4/0.

3. CALL TO THE PUBLIC

No comments were made by the public.

4. APPROVAL OF MEETING MINUTES - SVMPO Regular Meeting of September 23, 2015 (Attached)

Chair Mueller asked for a motion to accept the SVMPO Regular Meeting Minutes of September 23, 2015, as written. Vice Chair Searle so moved and Member Blanchard seconded. The motion passed unanimously, 4/0.

5. ANNOUNCEMENTS AND UPDATES

- ➤ Mr. Coxworth announced the Joint Planning Advisory Council Partnership Meeting on Friday, January 8, 2016. He explained that MPO planning directors meet periodically to discuss funding for transportation, including the raising of gas taxes which has recently gained support across organizations.
- Member Lane updated the Board on two projects still on track in the work program. The Foothills Safety Project is slated for the 2017 Fiscal Year and the Highway 92 Pavement Improvement Project from Highway 90 to Kachina Trail is slated for the 2018 Fiscal Year. ADOT is looking into completing both projects at the same time which would push both projects into the 2018 Fiscal Year. At the request of the Chair, Member Lane will also have ADOT look into expanding the pavement project north to Campus or Industry Drive.

PRESENTATION / DISCUSSION / ACTION

6. DISCUSSION / ACTION: Amended SVMPO By-Laws (Attached) - Dan Coxworth

SUMMARY: At the last Board of Directors meeting on September 23, the Board placed the amended bylaws in a 30-day public review period. Since that meeting the MPO has received comments from one member of the public.

The amendment includes minor changes located on pages 5 and 6. The changes affect voting membership to the SVMPO Technical Advisory Committee (TAC). Currently, TAC membership is determined by staff position title from member jurisdictions. The amendment will allow for the appointment of qualified City and County staff members to the TAC by respective City and County management.

Chair Mueller asked for a motion to approve the Amended SVMPO By-Laws as written. Vice Chair Searle so moved and Member Blanchard seconded. The motion passed unanimously, 4/0.

7. DISCUSSION: 2016 SVMPO Board Meeting Schedule (Attached) - Dan Coxworth

SUMMARY: In 2015 the Board of Directors met 6 times (including this meeting) almost every other month. The attached meeting schedule proposes scheduling meetings the third Thursday, every other month starting in January, 2016, with the possibility of the addition of special meetings should a need arise. Meeting will be cancelled if there is no business to be done that month. No objections were heard by the Board regarding the tentative schedule and were advised to contact Mr. Coxworth should any conflicts arise.
