Subject: Description of actions to be ratified

The Sierra Vista Metropolitan Planning Organization (SVMPO), Board of Directors convened on Wednesday, January 24th 2018, in a special meeting to vote on the following items:

- 1. Amend the SVMPO TIP to include \$938,963 Highway Safety Improvement Program funds.
- 2. Provide concurrence on amending the Sierra Vista Transit TIP to:
  - a. Utilize \$168,000 from the balance of FTA Grant No. AZ-2016-009-01 to purchase timekeeping software and a replacement 18 passenger bus
  - b. Extend FTA Grant No. AZ-2016-009-01 to September 30, 2019
  - c. Deobligate the remaining \$151,517

Due to time and date inconsistencies in the Public Notices of the above-described meeting, the actions taken by the SVMPO during that meeting require ratification to more fully comply with Arizona's Open Meeting Law.
