RE: Expansion of SVMPOs Metropolitan Planning Boundaries

This Letter Has been e-mailed to SVMPO Administrator for delivery to Board at January 2018 Board Meeting as I have just become aware of the Proposed Boundary Expansion.

Having spent at least two very unpleasant years defending our property rights and being subjected to threats of imminent domain and studies of our property being done with tax payer dollars awarded to SVMPO which eliminated pertinent facts when in fact our property was not within SVMPO planning boundaries, both Fred Bakarich and myself are not agreeable to any of the 400+ acres we privately own being taken into MPO's jurisdiction. SVMPO has no intention with working and communicating with stakeholders. It has been over a year since we offered a right of away at the very south end of our property (this is Connor Rd. Route in DCR) subject to terms and conditions to be agreed upon. This was presented to the SVMPO Board over a year ago. To date we have had no contact or communication. Now we find out through the attached "Press Release"????? that you are expanding SVMPO's planning area.

How many thousands of peoples' way of life (those who elect and prefer to live in a peaceful rural area and do not wish to be urbanized) will be affected because of a decision made by six individuals of which only one is a Cochise County official (SVMPO Board)?

Most people whether in or out of the SVMPO planning boundaries do not even know of it's existence. The average person does not sit at the computer all day checking out the various websites for notices and disclosures. Many do not have or want a computer! Even if one were to read Minutes, etc. to determine what is going on with Government the information is not detailed and a lot omitted.

I have communicated with several individuals to the East of Sierra Vista and they have no wishes to have roadways going through their property nor do they want to give up any land. Further, they do not want to become part of the "City". By-Laws can be rewritten. Politicians seem to forget they represent "the people" and should be looking out for their best interest instead of that of developers and government entities to benefit monetarily from these actions. At the very least something of this magnitude (expansion and impact of these boundaries) needs to be fully disclosed and voted upon by the citizens and residents of Cochise County. Where or where are the County Supervisors????? What about the ADOT representative who was o.k. with the SVMPO and the Engineering Company threatening us with imminent domain and allowing \$268,000 + to be spent on a study outside of the SVMPO boundaries.

There are a group of people that are looking into these matters and it may be that the Governor and the Attorney General need to investigate the impact of SVMPO'S activities on people's rights.

Dear Board,

I have the following comments about the proposed expansion of the boundaries for the Sierra Vista Metropolitan Planning Organization (SVMPO).

I see that some of the rules were changed somewhat recently and then rescinded just last month. So I'm not terribly clear on just what applies at the moment to the SVMPO. If any of the rules changes or rescissions applied to the MPO, I hope you are clear about what requirements you are complying with. Perhaps only minor changes would be needed to bring the SVMPO into compliance with the most recent rule changes.

I also note that the proposed boundaries encompass a lot of new land, at least some of which involves federal agencies. It looks to me that BLM land, U.S. Forest Service land (which may have already been a component member of the SVMPO), and the U.S. National Park Service, via the Coronado National Memorial, are now proposed for inclusion. Have those agencies been notified about their inclusion in the planning area? I think their input into decision making would be required going forward, just like the federal agencies are required to coordinate or cooperate with the county, etc. in planning issues. Perhaps some great partnerships for public transit stops for those visitor places can be part of future planning.

I'm also concerned about the public input and outreach that the SVMPO is required to do as a condition of receiving all those federal dollars. I think the outreach has been weak. Only the handful of people who have been paying attention to the SVMPO seem to be aware of the expansion plans. What has the MPO done for robust outreach?
